Participation in the Edutus LEGO Robot Camp General Terms and Conditions (GT&Cs)

For the purposes of these GT&Cs, the following words and expressions shall have the following meanings:

Edutus University refers to the company below:

Camp: Edu Robot Camp

Camper: a child considered as a minor within the meaning of Section 2:10 of Act V of 2013 on the Civil Code (Civil Code) who applies for the Camp as a participant.

Coach: an adult accompanying the Campers to the camp, they can be mentors or parents of the Campers. **Contract**: the contract entered into by and between the Camper and Edutus University, in accordance with the provisions of these GT&Cs.

Participation fee: EUR 450 or HUF 180,000 which includes the following services: accommodation, meals (three meals a day), professional program, qualified instructors. Travel costs to Miskolc are not included in the price.

Edutus University undertakes to organise a Camp for the Campers in accordance with the provisions of these GT&Cs and against payment of the Participation Fee; in the course of the Camp, it shall provide various services to the Campers.

1. The exact date and place of the Camp: 10-16 August 2025, Miskolc, Hungary

The duration and programme of the Camp, the services provided by Edutus University in the Camp and the Participation Fee shall be published on the www.wro.hu/edu-robot-camp/ website.

- **2.** The contract for participation in the Camp shall be concluded between Edutus University and the Camper by electronic means. The legal representative is entitled to act on behalf of a minor Camper under the age of fourteen, and the legal declaration of a minor Camper over the age of fourteen is valid with the separate consent of his/her legal representative.
- **3.** After having received the Application Form, Edutus University shall send an electronic message to the e-mail address provided on the Application Form as the e-mail address of the legal representative of the Camper, confirming the content of the Application Form and specifying the amount of the advance payment on the Participation Fee and the bank details (request for fee payment).
- **4.** The Contract shall be concluded between Edutus University and the Camper when the confirmation e-mail referred to in Clause 5 is sent by electronic means, in accordance with the Application Form detailed in the confirmation and these GT&Cs. The Contract shall be deemed to be a written contract and shall be concluded in English.
- **5.** By completing the Application Form and sending it to Edutus University by electronic means, the Camper's legal representative or, in the case of a Camper with limited capacity to act, also the Camper himself or herself shall acknowledge and voluntarily consent that all personal data of the Camper and his or her legal representative provided on the Application Form
- (a) shall be accessible to Edutus University, and may be collected, processed and used by Edutus University for marketing purposes; and
- (b) may be transmitted by Edutus University to Edutus University for the purpose of the successful organisation of the Camp, primarily in order to ensure the safe conduct of the camp, to preserve the

health of the Campers, to compile the educational and other programmes, as well as for marketing purposes, and may be processed and used by Edutus University for the same purposes.

The erasure of the personal data provided on the Application Form may be requested by the camper's legal representative, or in the case of a camper with limited capacity to act, by the Camper himself or herself, by sending an electronic message to international@wro.hu e-mail address.

6. Edutus University hereby informs the Camper and his or her legal representative that video, image and sound recordings (hereinafter referred to as Recording(s)) may be made inside the Camp and during the Camp, even in a manner suitable for the identification of the campers. The Recordings shall not violate the personal rights and dignity of the Camper. The sole proprietor of the Recordings shall be Edutus University. The purpose of the Recordings is to present the atmosphere of the Camp, the programmes organised and the results of the Camp. The Recordings shall be published primarily for marketing purposes, within the following scope: published on the www.edutus.hu and www.wro.hu websites, on the YouTube platform of Edutus University and the social media platforms of Edutus University and World Robot Olympiad Hungary (e.g., Facebook, Twitter, LinkedIn, Instagram). By completing the Application Form and submitting it to Edutus University, the Camper's legal representative and, in the case of a Camper with limited capacity to act, also the Camper himself or herself consents that the thus created Recordings may be used by the legal persons specified above, for the purposes and within the scope specified above, for an unlimited period of time, and the Camper and his or her legal representative shall not claim any consideration for the use of such Recordings. The camper's legal representative or, in the case of a camper with limited capacity to act, also the Camper himself or herself may at any time request the Recordings made of the Camper not to be used at all, to be used only to a limited extent, or to be deleted by sending an electronic message to the international@wro.hu e-mail address.

7. Due date for the payment of the Participation Fee

7.1. The Participation Fee shall be paid by the Camper/Legal representative of the Camper in two instalments. The first instalment, which is 50% of the Participation Fee, is due by 18 July. Payment for the second instalment is due before the start date of the camp.

Participation Fee – the amount indicated in the confirmation sent to the camper by Edutus University, which is EUR 450 / person or HUF 180,000 / person. An invoice for the amount shall be issued by Edutus University and sent to the Camper.

Edutus offers 30% discount for coaches when they bring a team of 2 or 3 to the camp. Furthermore, teams who win first place at their local WRO National Final also receive 30% discount. In this case the coach will not get any additional discount.

- **7.2.** All payments shall be made by bank transfer to the bank account specified on the proforma invoice. The following information shall be stated in the remark box of the transfer: *Edu Robot Camp 2025, invoice number and name of the team.* If these remarks are not stated appropriately, the payment shall not be considered by Edutus University to have been made.
- **7.3.** The proforma invoice shall be issued in electronic form. The proforma invoice issued in electronic form shall be sent as an attachment to a message sent to the e-mail address provided on the Application Form as the legal representative's e-mail address.
- **8.** Edutus University shall notify the Camper of the confirmation of the application and the information relating to the Camp by sending an electronic message to the e-mail address of the legal representative before the start date of the Camp. On the first day of the Camp, Edutus University shall register the Campers. In the course of the registration, the Camper or his or her legal representative shall be obliged to hand over to the representative of Edutus University the Declaration of Parental Responsibility and the Health Declaration concerning the Camper signed by the Camper's legal representative and, in the case of a camper with limited capacity to act, also by the Camper himself or herself.

- **9.** During the Camp, the Camper shall be supervised by Edutus University. The Camper's legal representative is required to inform Edutus University on the Application Form of any circumstances concerning the Camper that may affect safe supervision, in particular, but not exclusively, if the Camper:
- (a) takes some kind of medicine on a regular basis or taking the medicine needs to be monitored;
- (b) is allergic to any medicine, food or other substance, animal, etc;
- (c) may not engage in certain activities for any reason;
- (d) has food or drink intolerance;
- (e) may not participate in any Camp programme or event for any reason.

The legal representative shall be liable for all damages and any other harm resulting from the failure to give such information.

- 10. During the camp, Edutus University and the staff acting on its behalf shall take all reasonable measures and actions to ensure the safety of the Camp and its conduct in compliance with the legislation, in particular the provisions of the of Decree 12/1991 (IX. 29) of the Ministry of Welfare and Decree 37/2007 (VII.23) of the Ministry of Social and Family Affairs and the Ministry of Health. Edutus University, as well as the instructors and animators acting on its behalf, shall do their utmost to ensure that the Camp and the educational and recreational programmes are held to high standards.
- **11.** It is not possible to store valuable items or cash on the site of the Camp, therefore, Edutus University shall not assume any responsibility for the safety of such items.
- **12.** The Camper/Legal representative of the Camper acknowledge that the camper participates in the Camp's sports and other games at his or her own risk.

13. Duration and termination of the Contract

- **13.1.** The Contract concluded under these GT&Cs shall unless terminated earlier under these GTC continue until the Camp's end date. Notwithstanding the termination of the Contract, certain rights and obligations may, by their nature, continue to be exercised or performed after the termination of the Contract (e.g., use of the Recordings).
- **13.2.** The Camper/ Legal representative of the Camper shall have the right to terminate the Contract without giving any reason, subject to the payment of a forfeit money, as follows:
- **13.3.** The legal representative has the right to terminate the Contract in a proven and duly justified case (e.g., for a proven health reason) and to remove the camper from the Camp, in which case he or she may claim a refund for the part of the Participation Fee that is proportional to the time not yet elapsed from the total duration of the Camp until the removal of the Camper.
- (a) if the termination takes place within 1 week before the start date of the Camp (on 3 August 2025 or later), the paid participation fee shall not be refunded
- (b) if the termination takes place more than 1 week prior to the start date of the Camp (on 2 August 2025 or earlier), 50% of the paid participation fee shall be refunded.
- **13.4.** Edutus University shall be entitled to terminate all Contracts of the Camp in the event that the Camp's organisation fails for an unexpected reason. In this case, Edutus University shall be obliged to refund exclusively the already paid Participation Fees and shall not be obliged to make any other payments on any legal basis.
- **13.5.** The Contract shall terminate without any further provision or declaration if the Participation Fee is not paid by the date set on the proforma invoice/invoice issued for the Participation Fee or if the payment thereof is deemed to be in default under these GT&Cs on the first working day following the due date.

- **13.6.** Edutus University may terminate its Contract with any Camper/ Legal representative of the Camper with immediate effect in the event that the Camper concerned
 - a. (a) repeatedly violates the rules of the Camp;
 - b. (b) seriously violates the rules of the Camp;
 - c. (c) deliberately causes damage;
 - d. (d) coerces, threatens, or abuses another Camper.

In the event of immediate termination, the legal representative is obliged to promptly remove the Camper from the Camp. In the event of termination with immediate effect, Edutus University shall not be obliged to refund the Participation Fee either in part or in full.

13.7. If Edutus University is obliged to refund the Participation Fee paid, either in part or in full, it shall pay such amount by transfer to the bank account from which the payment of the Participation Fee to Edutus University was made. Any claim by Edutus University may be offset against the refundable Participation Fee.

14. Damages, compensation

- **14.1.** By submitting the Application Form to Edutus University, the Camper's legal representative acknowledges and agrees that in lieu and on behalf of the Camper he or she shall reimburse all damages arising from any non-contractual or unlawful conduct displayed by the Camper during the Camp, regardless of whether the legal representative is otherwise legally obliged to reimburse such damage, provided that the harmful conduct is not in a cause-and-effect relation with the any conduct attributable to Edutus University in connection with the supervision of the Camper. This obligation to pay compensation for damages imposed on the legal representative shall apply to any damage incurred by Edutus University, any other Camper or any other third person.
- **14.2.** In the event of the Campers' harmful conduct, Edutus University shall notify the legal representative as soon as possible if the circumstances of the damage so permit. Edutus University shall draw up a report of the damage, if the circumstances of the damage so permit, which may also be signed by the legal representative.
- **14.3.** Edutus University shall be responsible for organising the Camp with due care, taking into account the provisions of the legislation, these GT&Cs and the data set out on the Application From, and for supervising the Campers with due care. Accordingly, it shall be liable for damages directly attributable to any breach whether deliberate or negligent of any applicable law, any provision of these GT&Cs or any disregard whether deliberate or negligent of or conduct contrary to any provision or information contained in the injured Campers' Application Form. If Edutus University is obliged to pay compensation for damages due to any conduct, then it shall only be obliged to reimburse the pecuniary damages caused directly, therefore, it cannot be required to pay lost profits or forfeit money.
